Sub.: Seniority list of Inspector of Police in CBI and judgement dated 16/12/2009 of Hon'ble Supreme Court of India in Civil Appeal No. 1485/2003 (CBI Vs D. P. Singh) - regarding.

It has been observed that departmental Inspectors of CBI are representing for rectification in the seniority list of Inspectors issued on 1.1.2010 in respect of fixation of seniority of absorbee Inspectors and fixation of their seniority in the light of judgement dated 16/12/2009 of the Hon'ble Supreme Court of India in Civil Appeal No. 1485/2003 in the case of CBI versus D.P. Singh, who was absorbed in CBI as Dy. SP w.e.f. 29.6.87.

Representations of Inspectors posted in various branches of CBI have been examined in detail and it has been found that seniority of absorbees/departmental Inspectors of CBI issued as on 1.1.2010 is in order and fixed correctly in accordance with DP&T Office Memorandum No. 20011/1/2000-Estt. (D) dated 27/03/2001, based on the judgement in SI Rooplal Vs Lt. Governor through Chief Secy., Delhi 1999(9) SC 597, effective from December 14, 1999.

*As per order No. 27012/1/97-PC Cell/PF.I dated 10/10/1997 of MHA pay scale of Inspectors in CPOs (including CISF) (Rs. 1640-2900) was upgraded to the pay scale of Rs. 2000-3200 (pre-revised)/Rs. 6500-10500 (Pre-revised) and made equivalent to the pay scale of Inspectors in CBI. This upgradation was made effective from the date of issue of the aforesaid order i.e. w.e.f. 10/10/1997. Accordingly, the aforesaid absorbee Inspectors were treated as holding post equivalent to the post of Inspector from the date of deputation in CBI.

Further, Supreme Court judgement dated 16/12/2009 in Civil Appeal No. 1485/2003 in the matter of Shri D.P. Singh Vs CBI **is not applicable** in respect of fixing seniority of Inspectors in CBI as the matter/absorption of Shri D. P. Singh as Dy.SP in CBI relates as per the guidelines issued by Department of Personnel and Training (DOPT) vide office memorandum dated May 29, 1986.
