ENGAGEMENT OF LAW OFFICERS ON CONTRACTUAL BASIS IN CBI

Looking for bright legal brains, who are keen to work with the Country's Premier Investigation and prosecuting Agency for appointment as Law Officers (Public Prosecutors) on contractual basis initially for a period of 01 year which can be extended upto 03 years at a consolidated remuneration not exceeding Rs.60,000/- per month. The person engaged shall have no right to claim regularization/absorption in the organization after the expiry of period of contract.

2. The Law graduates with minimum 10 years of experience at the Bar in conducting criminal cases in the Court of Law are eligible for appointment to the above mentioned post. The candidates will be on whole time appointment and will have no right of private practice during the period of contract.

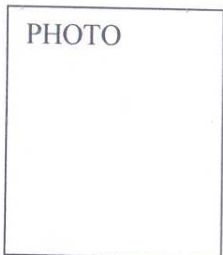
